Oscar reviewed the recent financial reports. Approximately \$42,000 needs to be transferred to an account determined by Vestry. There is \$112,000 available for operations. We are in a more positive situation today than in the past three years. An update was given regarding operating account, capital account and restricted expenditures. Income collections are positive.

Vestry had a discussion regarding Wednesday Night Supper costs. Supplies may need to be re-allocated to another area. Amy will send out information via email.

<u>Capital Campaign Report</u> (Brian Martin)

Announcements were made during services regarding the Capital Campaign. We anticipate a significant amount of pledges to come in. Vestry will discuss Capital Campaign at the September Vestry meeting.
