#### Minutes

Minutes from the February were reviewed.

Bob Williams made the motion to accept the minutes as written. Sloan McKellar seconded the motion which passed unanimously with aye.

# Finance Reports (Oscar Hartman)

Oscar Hartman reviewed the financial reports from January 2016 and February 2016. After discussion, Bob Williams made the motion to accept the combined January and February financial reports. Tell Flowers seconded the motion which passed unanimously with aye.

## Senior Warden's Reports (Davis Frye)

Davis reported that he has gotten a good response from Chapel members following the announcement that we have decided to move forward with a capital campaign. People are excited!

## Junior Warden's Report (Jon Woodward)

Jon is in the process of transitioning the junior warden responsibilities and open project list from Bill Buhner to himself. Key projects include:

- Response to potential management company we will politely decline/postpone indefinitely
- Deweese House repairs
  - o Fans have been requested to distribute the heat need an electrician to safely install
  - o Shingles need to be replaced
  - o Fence couplings need to be repaired
  - o The outside needs to be painted
- Deweese House apartment repairs
  - o Outside security light/stairwell light installed for safety
  - Leak in ceiling fixed
- Skunks were relocated from Chapel grounds and entrance to chapel was sealed with mesh
- Ernie re-grated driveway and replaced rocks that had been scattered
- Toilets were fixed/re-seated
- David Cado is procuring light ballasts for the offices and hallways in the parish hall
- Repairs and cleaning are being planned for damage caused by the fire in the parish hall. There is a need to coordinate regarding:
  - o Replacement of table (Mandy Pope may have already procured another table)
  - o Selection of replacement tiles for flooring
- Fire extinguisher will be recharged
- Parent's Day Out requests
  - o Shaded area in playground
  - o Process/Procedure documented to complete fire drills
  - o Emergency Plan
  - o Ability to close and lock iron gates for security
  - o Overall church emergency plan
  - o Repairs to prevent water leakage in first classroom
  - o Repair door lock on Atrium 1
  - o Remove rug by Janet King's office
  - Fix drain in courtyard

**Action:** Ben to reach out to PDO director to understand legal requirements for licensure, timelines and next steps.

**Action:** Jon to schedule cleanup day prior to Easter Sunday

**Action:** Ben/Jon to contact exterminator to understand what is included in current pest control contract (frequency and scope) as well as what it would take to increase/improve.
