- i. Accounting Corrections
 - --\$42,900 income for September 2020 (\$88,000 budgeted)
 - --Net income YTD is \$52,000 below expected amount for the year
 - --Members with outstanding pledges will be contacted to donate before EOY 2020
- ii. Plans for 2020-2021
 - --moving into 2021 we will be in a better place financially
 - --asking vestry to allow movement of \$107,751.07 from operating account to capital campaign
 - Motion to move this amt made by Tommy, Bill 2nd, unanimously approved by the Vestry's vote
 - --\$68,050 raised for pews/choir chairs/BCPs/hymnals
 - --PPP is still in good shape
