--organ company is behind schedule; delivery now scheduled for January 2022

1. Bear Creek Water report/update

--presented with 3 options by Bear Creek; final offer net cost estimated to be \$28,286

--next step is to contact Probity with estimate

--motion to accept lawyer's recommendation to withhold \$67,000 from Probity and pay \$17,096 to Barlow Eddy Jenkins; motion made by Reggie, seconded by Rebecca, unanimously approved by the vestry's vote
