- A. Treasurer's Report
  - 1. 2021 Budget and January Financials
    - --Brock summarized budget—we are in a good position financially
    - --we will not qualify for second round of PPP loans from federal govt.
    - --discussion of budget
    - --finance committee passed the budget with a deficit
      - Reggie proposed an amendment to 1. reduce budgeted pledge amount to 97% of pledges in 2021 budget and 2. Reduce diocesan VPG to \$50, 000 from \$65,000 (will revisit this in the summer) to help reduce deficit amount in budget
      - Tommy called the question; 2 opposed, 8 yeas; amendment passed

--overage of pew donation funds will cover the extra cost
