# Amendment to the By-laws of the Parish of The Chapel of the Cross Madison, Mississippi

In order to comply with Canons of the Episcopal Church, Article V, section C of the By-laws of The Chapel of the Cross, Madison, Mississippi is hereby amended as follows to wit:

### Section C

The duties of the Wardens shall be set forth in Canon Law. Unless it conflicts with the law of the State or of the Dioceses, the Rector, or such other member of the Vestry designated by the Rector, shall preside in all meetings of the Vestry.
