- Vestry Guests
 - ➤ Entergy, Cliff Hering (subcontractor)
 - -Presented a proposal to
 - a)put new electrical poles up at southeast corner of property (Gluckstadt Rd and 463) and further south toward entrance/driveway
 - b)replace existing pole south of Deweese house exit
 - -oak tree and crepe myrtles will need to be removed from our property in order to accommodate these changes
 - -we would need to approve allowing Entergy to take the easement on our property to place the poles
 - -discussion; suggested to put lines on Rita McGuffie's property across 463 because an easement for the lines already exists there; according to Mr. Hering there were concerns about the trees on her property so they came to us
 - -other concerns voiced by Mr. Herren, Mr. Cato, and Mr. Balentine
 - -members of vestry would be possibly be amenable to this (pending review of easement) if lines are buried and not visible
 - -Kenny moved to deny the request for the easement as it stands currently, 2nd by Bill
 - ➤ Dr. Ed Dacus, Director of Music @ The Chapel of the Cross
 - -Husband and wife Ausra and Hristov Jasineviciute want to use the choir room at the Chapel to meet with advanced strings students they teach in private lessons from around the metro area; have asked Ed if they can use the facility on Saturdays from 1-3 starting in Sept 2023
 - -discussion of insurance/liability waiver; tabled pending Michael discussing with Dana re: insurance/liability, as well as Ed following up re: background checks for Ausra and Hristov to be in accordance with Safeguarding God's Children policies
